

**ORDINANCE NO 14-012**

**AN ORDINANCE AMENDING THE ANNUAL BUDGET ORDINANCE FOR FISCAL  
YEAR JULY 1, 2013 THROUGH JUNE 30, 2014**

**SUMMARY**

**GENERAL FUND**

Property Taxes are increased by \$100,000. Occupational License Fees: Net Profits are increased by \$450,000. Electrical Permit revenue is decreased by \$50,000. Intergovernmental Revenues are increased by \$260,063. General Government expenditures are increased by \$21,131. Police Department expenditures are increased by \$29,525. Public Works expenditures are increased by \$30,050. City Council expenditures are increased by \$14,000. City Clerk expenditures are increased by \$8,600. Building Inspection expenditures are increased by \$7,000. Community Services expenditures are increased by \$12,938. Transfers to Other Funds are decreased by \$63,000.

**RECYCLING FUND**

Prior Year Revenues are increased by \$31,663. Intergovernmental Revenues are decreased by \$10,663. Recycling expenditures are increased by \$21,000.

**LANDFILL FUND**

Prior Year Revenues are increased by \$2,994. Landfill expenditures are increased by \$17,794.

**DRUG FORFEITURE FUND**

State Revenues are increased by \$39,880. Expenditures are increased by \$25,000.

**BUSINESS PARK FUND**

Revenues from Sale of Property are increased by \$95,895. Transfers from Other Funds are decreased by \$63,000.

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed. This ordinance shall take effect after its passage and publication according to law.







**ORDINANCE # 14-012**

**AN ORDINANCE OF THE CITY OF GEORGETOWN, KENTUCKY, AMENDING THE ANNUAL BUDGET FOR THE FISCAL PERIOD JULY 1, 2013, THROUGH JUNE 30, 2014**

**SPONSORS: COUNCIL MEMBER CONNIE TACKETT**

**NOW THEREFORE, BE IT ORDAINED BY THE CITY OF GEORGETOWN, KENTUCKY, AS FOLLOWS:**

**SECTION ONE**

The annual budget for the fiscal year beginning July 1, 2013 and ending June 30, 2014, adopted on July 2, 2013, by Ordinance 13-014 and amended on March 24, 2014 by Ordinance 14-005, is amended as set forth in Exhibit A attached hereto and incorporated herein by reference.

**SECTION TWO**

Except as provided in the Georgetown Purchasing Policy adopted in Municipal Order 11-028, the Mayor is hereby authorized to enter into any contracts or agreements necessary to fulfill the operation of City government within the allocations listed in this ordinance.

**SECTION THREE**

If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held unconstitutional or otherwise invalid, such infirmities shall not affect the validity of the remaining portions of this ordinance.

**SECTION FOUR**

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

**SECTION FIVE**

This ordinance shall take effect after its passage and publication according to law.


