AN ORDINANCE CLOSING A PORTION OF THE RIGHT OF WAY KNOWN AS BARKLEY LANE

IN THE CITY OF GEORGETOWN, KENTUCKY

Now, therefore be it ordained, by the City of Georgetown, Kentucky, as follows:

**SECTION ONE** 

The Georgetown City Council hereby makes findings of fact pursuant to KRS 82.405(2):

that Cyron Holdings, LLC and Vojecaro Properties LLC, are the only owners of property abutting

the right of way to be closed; that they were provided written notice of the proposed road

closing; and, that said owners have given written, notarized consent to the right of way closing,

copies of which are attached hereto and incorporated herein by reference as Exhibit A.

**SECTION TWO** 

The right of way known as Barkley Lane, from its intersection with Delaplain Rd. to the

southern border of the properties owned by Cyron and Vojecaro, being approximately 1 1/2

acres and more particularly described in the plat recorded in Plat Cabinet 11, slide 356, Scott

County Clerk's Office, a copy of which is attached hereto and incorporated herein by reference

as Exhibit B be, and the same is hereby, closed as a public way.

SECTION THREE

If any portion of this Ordinance is for any reason held invalid or unlawful such portion

shall be deemed a separate provision and such holding shall not affect the validity of the

remaining portions of this Ordinance.

SECTION FOUR

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

**SECTION FIVE** 

This Ordinance shall be in full force and effect upon passage and publication.
